
# **Understanding your bill**



## 1. Bill-specific information:

- a. **Service period dates:** The service days included in this bill. Note: The number of days in a billing period may fluctuate due to weekends, holidays, or changes in the date we read your meter.
- Account number: Unique identifier for the customer at this address – refer to this number if you contact Gulf Power about your account.
- c. **Service address:** Location where electricity is being provided.
- 2. Total amount due: This is for services already used during the billing period plus any outstanding service charges, deposits or late payment fees incurred.
- **3. New charges due by:** This is when payment for new charges is due.
- 4. Bill summary: A high-level breakdown of the total amount due.

- How to contact Gulf Power: You can complete many important tasks online at GulfPower.com or you can call us.
- Energy usage history: Illustrates the monthly kilowatthours (kWh) used for the last 12 months.
- **7. Bill messages:** Important information that can benefit our customers.
- 8. Customer contact information: Name associated with the service account, and the address requested to have communications sent.
- 9. Payment mailing address: Location to send a check payment for this bill.

- 10. Rate: Determines how the bill is calculated for
- 11. Total "electric service amount" is made up of the following charges:

**Electric service amount:** These charges are regulated by the Florida Public Service Commission and are explained on of the following charges:

- a. Base charge: A fixed monthly amount to cover the includes the cost of the meter, billing and providing
- b. Energy charge: This total charge is made up of the following charges:
  - » Base energy charge: The costs, other than fuel, to produce and deliver electricity, including the cost of operating power plants, and maintaining the grid.
  - » Energy Conservation Cost Recovery Charge (ECCR): Cost of programs designed to reduce
  - for purchasing electricity from non-Gulf Powe
  - » Environmental Cost Recovery Clause (ECRC): Cost
- c. Fuel charge: The cost for fuel required to provide each kilowatt-hour (kWh) of electricity. Gulf Power

- 12. Taxes and charges: Taxes and fees may vary by area, Gulf Power collects these costs for distribution to the amount is made up of the following charges
  - a. Gross receipts tax: A tax on a customer's electric bill that is paid to the State of Florida.
  - b. Franchise charge: Fee on a customer's electric bill appropriate local municipality or county government.

### 13. Meter summary:

- a. Meter number: Unique identifier associated with your electric bill.
- b. Next meter read date: Date next meter reading is scheduled to take place.
- 14. Energy usage comparison: Compares the kilowattenergy usage.
